The Honorary Director will occasionally work at the Presidents direction on special projects or programs as deemed necessary.

Secretary of FJSNA The Secretary is primarily responsible for recording FJSNA's activities and proceedings; tabulating and recording votes; publishing announcements, and managing/securing the

FJSNA website and social media profiles.

Treasurer of FJSNA

The Treasurer is primarily responsible for the financial affairs of FJSNA, including but not limited to; maintenance of accounts in all financial institutions; the receipt, investment, and disbursement of funds; documenting with receipt such transactions; and providing detailed reports regarding the state of FJSNA finances on demand, and at every EXCOM or full committee (FULLCOM) meeting, and to the general membership as required.
